- Approved the minutes of the July 10, 2017 Board Meeting.
- Approved the July Financial Report as presented by the Treasurer.
- Approved the payment of July Bills as presented by the Treasurer.
- Approved Landers-Lewis Insurance Agency as a provider of insurance coverage for the District from September 1, 2017 through September 1, 2018.
- Approved continued membership with the Ohio Coalition for Equity and Adequacy of School Funding for the 2017-2018 school year.
- Accepted the resignation of Lisa Saxon, a certified employee, effective August 14, 2017.

- Employed Susanne Silvernail as a math teacher for the High School on a one-year limited contract, effective August 25, 2017 through June 1, 2018.
