- Approved the minutes of the June 21, 2017 Regular Board Meeting, along with the June 21, 2017 and June 28, 2017 Special Board Meetings.
- Approved the June Financial Report as presented by the Treasurer.
- Approved the payment of June Bills as presented by the Treasurer.
- Approved Student Activity Account Budgets as presented by the Treasurer.
- Approved Permanent Annual Appropriations for fiscal year ending June 30, 2018 as presented by the Treasurer.
- Approved Margaret Kowach as an Ohio Department of Education Credentialed Techer Evaluator valid through June 22, 2019.
- Accepted the resignation of Chelsi Moore, LaBrae High School Math Teacher, effective August 15, 2017.
- Approved the resignation of Chelsi Moore as the High School Student Council Advisor, effective August 15, 2017.
- Approved the resignation of Lynn Gilbert as the 2017-2018 Boys Bowling Coach effective immediately.
- Adopted a resolution stating that the Board will not provide career-technical education to students enrolled in grades seven and eight for the 2017-2018 school year.
- Agreed to participate in a cooperative agreement contract with the Trumbull County Educational Service Center, other Participating School Districts and Community Bus Services, Inc., for the transportation of disabled students attending cooperative special education classrooms out-of-district in Trumbull County, effective July 1, 2017.
