Greetings: The LaBrae BOE held their regular monthly meeting Monday, February 12, 2018, in the Library at Bascom Elementary, and conducted the following business:

- Approved the minutes of the January 8, 2018 Organizational and Regular Board Meetings.
- Approved the January Financial Report as presented by the Treasurer.
- Approved the payment of January Bills as presented by the Treasurer.
- Approved the disposal of fixed assets on the List of Dispositions with Item Data as presented by the Treasurer.
