Greetings: The LaBrae BOE held their regular monthly meeting Monday, February 12, 2024, in the Complex Band Room and conducted the following business:

- Approved the minutes of the January 8, 2024 Organizational and Regular Board Meetings.
- Approved the January Financial Report as presented by the Treasurer.
- Approved a resolution declaring support for the Fair School Funding Plan.
- Approved the employment of Clint Elston for a 60-day probationary period as an afternoon custodian at Bascom Elementary, effective January 22, 2024, at an hourly rate determined by the Superintendent, but in accordance with the applicable rules and regulations articulated in the negotiated agreement between the Board and OAPSE Local 278, and upon satisfactory completion of the probationary period, as determined by the Superintendent employ Clint Elston on a one-year limited classified contract with an effective date of January 22, 2024.
- Approved Valerie Staley as a special education tutor to deliver specifically designed instruction (SDI) minutes to special education students, effective October 24, 2023 through May 30, 2024.
- Approved Karen Mullenax as a special education tutor to deliver specifically designed instruction (SDI)
 minutes, effective January 16, 2024, at a rate specified amount, for each day of SDI delivery through the
 conclusion of the 2023-2024 school year.
- Approved an unpaid medical leave of absence for a classified bargaining unit member, in accordance with the negotiated agreement with OAPSE 278, Article VII, Section C, effective January 16, 2024 through March 8, 2024.
- Approved the 2024-2025 Academic School Calendar.
- Approved continuation of the Inter-District Open Enrollment Policy and Guideline for the LaBrae Local School District for the 2024-2025 school year, for open enrollment students from all other districts.
- Approved the Memorandums of Understanding for the College Credit Plus program, which will allow secondary school students to enroll in college level courses to receive college credit during the 2024-2025 school year, with the following higher level educational institution: Kent State University and Youngstown State University
- Approved additional athletic supplemental positions for the 2023-2024 school year.
- Hired Diane Downey as the Girls Head Varsity Soccer Coach for the 2024-2025 school year.
