- Approved the minutes of the June 10, 2019 Regular Board Meeting and the June 26, 2019 Special Board Meeting.
- Approved the June Financial Report as presented by the Treasurer.
- Approved the payment of June Bills as presented by the Treasurer.
- Approved the Student Activity Account Budgets as presented by the Treasurer.
- Accepted the Permanent Annual Appropriations as presented by the Treasurer for fiscal year ending June 30, 2020.
- Authorized membership for LaBrae Local Schools in the National Cooperative Purchasing Alliance at no charge to the district.
- Approved a contract with Vasco Sports Group for track resurfacing, effective 2018-2021, procured through the National Cooperative Purchasing Alliance.
