- Approved the minutes of the May 12, 2014 Regular Board Meeting.
- Approved the May Financial Report as presented by the Treasurer.
- Approved the payment of May Bills as presented by the Treasurer.
- Approved per the adopted LPDC Bylaws of Operation Article V - Meetings Section C.
- Approved an Environmental Covenant with the Ohio E.P.A. and authorized the Treasurer to execute it.
- Approved academic supplemental contracts for the 2014-2015 school year.
- Approved sport supplemental contracts for the 2014-2015 school year.
