Greetings: The LaBrae BOE held their regular monthly meeting Monday, June 8, 2020, in the Complex Band Room, and conducted the following business:

- Approved the minutes of the May 11, 2020 Regular Board Meeting.
- Approved the May Financial Report as presented by the Treasurer.
- Approved the payment of May Bills as presented by the Treasurer.
- Approved the receipt of \$194.03 received from Sam's Club Cash Back Rewards and authorized the Treasurer to deposit the money in the Viking Pantry fund.
- Authorized the Treasurer to transfer \$1,300.05 from the general fund to the cafeteria fund to retire 2019-2020 student lunch debt, and transfer the debt to student fee accounts in accordance with Board policy 8500.
- Revised resolution number 100-20 from the May 11, 2020 regular Board meeting to award the bid to Murphy Construction for the Bascom Elementary office remodeling project to show the Base Bid of \$143,800 and the Alternate G-1 as \$2,900.
- Approved the Memorandum of Understanding with the LTA on payment of supplemental contracts due to the COVID-19 Pandemic.
- Authorized the request, pending Ohio Department of Education approval, to participate in a Summer Food Service Program offered by the Child Nutrition Division of the Ohio Department of Education.
- Approved the following cafeteria prices for the 2020-2021 school year, per the standards set forth by USDA and the State Child Nutrition Department.
