Greetings: The LaBrae BOE held their regular monthly meeting Monday, June 13, 2022, in the Complex Band Room, and conducted the following business:

- Approved the minutes of the May 9, 2022 Regular Board Meeting.
- Approved the May Financial Report as presented by the Treasurer.
- Approved a resolution permitting the Board to acquire goods and services through the use of an "open purchase order" which is limited to a certain purpose and the money for which is in the treasury.
- Approved a resolution authorizing the Board of Education to enter into a cooperative transportation agreement with the Trumbull County Educational Service Center and Community Bus Services, Inc.
- Accepted the resignation of certified employee, Lauren Eckman, Intervention Specialist at Bascom Elementary, effective August 26, 2022.
- Accepted the resignation of classified employee, Russell "Shorty" Daniels, Transportation Mechanic, due to retirement effective July 1, 2022.
- Authorized the request, pending Ohio Department of Education approval, to participate in a Summer Food Service Program offered by the Child Nutrition Division of the Ohio Department of Education.
- Approved classified cooks for participation in the summer meals program with hours to be determined by the cafeteria supervisor per Article X, Section G of the negotiated contract with OAPSE Local 278.
- Approved cafeteria prices for the 2022-2023 school year per the standards set forth by USDA and the State Child Nutrition Department.
