Greetings: The LaBrae BOE held their regular monthly meeting Monday, June 12, 2023, in the Complex Band Room, and conducted the following business:

- Approved the minutes of the May 8, 2023 Regular Board Meeting.
- Approved the May Financial Report as presented by the Treasurer.
- Approved a resolution permitting the Board to acquire goods and services through the use of an "open purchase order" which is limited to a certain purpose and the money for which is in the treasury.
- Approved the establishment of a fund for participation in Ohio's School Safety Grant Program and the corresponding appropriation amount of \$15,258.00.
- Authorized the Treasurer to transfer \$9,688.85 from the general fund to the cafeteria fund to retire 2022-2023 student lunch debt, and transfer the debt to student fee accounts in accordance with Board policy 8500.
- Approved a renewal contract for FY2024 with the Nutrition Group for cafeteria operations and management services, which is year 2 of 5.
- Authorized the request, pending Ohio Department of Education approval, to participate in a Summer Food Service Program offered by the Child Nutrition Division of the Ohio Department of Education.
- Approved classified cooks for participation in the summer meals program with hours to be determined by the cafeteria supervisor per Article X, Section G of the negotiated contract with OAPSE Local 278.
- Approved cafeteria prices for the 2023-2024 school year per the standards set forth by USDA and the State Child Nutrition Department.
