Greetings: The LaBrae BOE held their regular monthly meeting Monday, May 9, 2022, at the Braceville Township Hall, and conducted the following business:

- Approved the minutes of the April 11, 2022 Regular Board Meeting.
- Approved the April Financial Report as presented by the Treasurer.
- Approved the revised Five-Year Forecast as presented by the Treasurer.
- Acknowledged the receipt of bids for cafeteria management services for fiscal year 2023 from the following company: The Nutrition Group.
- Accepted the following company as the successful bidder for cafeteria management for fiscal year 2023, effective July 1, 2023: The Nutrition Group.
- Approved the request for continued participation in State and Federally funded programs for the 2022-2023 school year.
- Accepted the resignation of classified employee, Carol Shanower, Intermediate Library Aide, due to retirement effective June 1, 2022.
- Approved Juneteenth, June 19<sup>th</sup>, as a paid holiday for all 11 and 12 month regular classified employees in accordance with revisions to Ohio Revised Code 3319.087, effective June 10, 2022.
