Greetings: The LaBrae BOE held their regular monthly meeting Monday, September 13, 2021, in the Complex Auditorium and conducted the following business:

- Approved the minutes of the August 9, 2021 Regular Board Meeting.
- Approved the August Financial Report as presented by the Treasurer.
- Accepted Permanent Annual Appropriations as presented by the Treasurer for fiscal year ending June 30, 2022.
- Approved the Amended Certificate of Estimated Resources as presented by the Treasurer for the fiscal year ending June 30, 2022.
- Approved Federal Grant Funds and the Allocation amounts for them.
- Approved FY2022 contract with the Trumbull ESC for public relations/communications support.
- Approved a revised Fiscal Year 2022 Excess Costs Foundation Contract with the Trumbull County ESC to be deducted from State foundation payments to the LaBrae Local School District.
- Approved a resolution regarding the Class of 2022's Graduation Flexibility in response to the ongoing challenges presented by COVID-19, it is anticipated that the pandemic will continue to impact school operations during the 2021-2022 school year.
- Accepted the voluntary transfer of Michael Seafert to the Middle School Custodian position, effective October 1, 2021.
- Employed Matthew Bartholomew, as a 5-hour complex custodian, on a one-year limited contract, effective August 30, 2021.
- Approved the supplemental contract for Margaret Kowach as the Title I Coordinator for the fiscal year 2021-2022.
- Accepted the resignation of Kendra Wirtz as Instructional Tutor, effective August 23, 2021.
- Employed Angela Rogers as an Instructional Tutor, effective August 26, 2021.
- Approved Renee McManus as a substitute nurse, on an as needed basis, effective August 31, 2021.
- Approved the revised LaBrae Local Schools' Hall of Fame bylaws as submitted by the Superintendent.
- Approved the bus routes for the 2021-2022 school year, and authorize the superintendent, or Superintendent Designee, to make changes throughout the year as necessary.
- Approved the tuition rate of \$3,757.03 for the 2021-2022 school year as set by the State of Ohio's Department of Education Office of Budget and School Funding.
- Approved the LaBrae Local Schools' Special Education Procedural Handbook.
- Approved Mr. Starkey and Mr. Rowe as credentialed teacher evaluators under the Ohio Teacher Evaluation System, effective August 13, 2021 through August 13, 2023.
- Amended resolution number 168-21 from the July 12, 2021 regular Board Meeting to reflect Carly Jones as the J.V. Cheerleading Advisor and Alexa Nogales as the 7<sup>th</sup> & 8<sup>th</sup> grade Cheerleading Advisor.
