Greetings: The LaBrae BOE held their regular monthly meeting Monday, June 13, 2011, at the Complex Auditorium and conducted the following business:

- Recognized and presented a plaque to Howard Ulbricht, classified employee, and accepted his resignation due to retirement, effective May 31, 2011.
- Approved professional leave for certified and classified staff.
- Approved supplemental contracts for certified and non-certified personnel for the 2011-2012 school year.
- Accepted the resignations of Terry Armstrong and Marilyn Russo, teachers, effective June 2, 2011.
- Approved the amended 2011-2012 school calendar.
- Approved the LaBrae Middle School student and staff handbooks for the 2011-2012 school year.
- Approved the renewal of the district's athletic insurance policy with Baker Insurance Company.
- Accepted the following donations: a guitar and a flute from Tom and Ruth Reilly, a trumpet from Robin Schoonover, a clarinet and a trumpet from Chuck and Linda Parker, a clarinet from Tanya Neff, a trumpet from Greg Bartholomew, a Dell computer, monitor, keyboard and mouse from Paula Cole, and a Dell computer tower from Teresa Frederick.
- Approved per the adopted LPDC Bylaws of Operation Article V - Meetings Section C.
- Approved a summer intervention program for students who will be in grades 3 and 4 for the 2011-2012 school year, to be held August 8 – August 21, 2011.
- Approved a resolution permitting the Board to acquire goods and services through the use of an "open purchase order" which is limited to a certain purpose and the money for which is in the treasury.
- Approved an *Athletic Trainer Services Agreement* with Competitive Edge Sports Medicine.
- Approved the school lunch prices for the 2011-2012 school year as follows:

High School (Grades 9 – 12)	\$2.10
Middle School (Grades 6- 8)	\$1.85
Bascom and Intermediate (Grades K – 5)	\$1.60
Milk (All Grades)	\$0.50
A la Carte pricing	\$0.10 – \$3.00

- Employed Anthony J. Calderone as Interim Superintendent effective June 23, 2011 through July 31, 2011 on an as needed basis only.
